## 'BJP insulting farmers': Kejriwal urges people to change system in polls

### Big match energy

ENTHUSIASM REACHED its peak during the ICC T20 World Cup final match between India and New Zealand in Ahmedabad on Sunday. Two BJP MLAs made special arrangements to ensure that people of their respective constituencies watch the match together on big LED screens. In Ahmedabad city, Dariapur MLA Kaushik Jain made the arrangements at the public relation office of his constituency in Dariapur. Viramgam MLA Hardik Patel made the arrangements at Ganesh Pandal Maidan in Viramgam town. Clad in a blue team India T-shirt, Hardik was seen watching the match with the cricket enthusiasts at the place while also doing a live commentary.

LAUNCHING A scathing attack on the ruling BJP in Gujarat, Aam Aadmi Party (AAP) chief Arvind Kejriwal on Sunday called upon people of Gujarat not to change a party but the entire system in the 2027 Assembly elections in the state.

Kejriwal was addressing a public gathering in Gandhinagar marking the conclusion of the party's 'Parivartan Lao, Kisan Bachao Yatra'.

Kejriwal is on a two-day visit to Gujarat. This is his first visit to the state after a Delhi court discharged him in the excise policy 'scam'.

Alleging the BJP of committing atrocities on farmers, Kejriwal referred to a case in Botad in October last year when dozens of farmers and AAP leaders were arrested by police following a clash at a meeting at Hadadad village of the district.

Referring to the case, Kejriwal said, "The BJP wants to give a message to the farmers of the entire Gujarat that if they raise their voice then they will face the same consequences...The BJP is openly insulting the farmers." He added, "In elections this time, every farmer has to take oath that they give their vote to anybody, but not to BJP; (That) lotus will be uprooted from Gujarat."

Kejriwal cited instances of various AAP leaders, who raised voice for people and were jailed by the BJP governments. "These people (BJP) did not spare me either. They jailed me too; a sitting CM of Delhi for six months. It has never happened in the history of 75 years.

They alleged that I did corruption of Rs 100 crore. That Kejriwal did a liquor scam...The five biggest leaders of our party were jailed by them. They jailed me while dragging me from my home in the night hours...They raided my home, my bank, my office. Not a single paisa was found...Where did Rs 100 go?" he said.

"Now, the court order has come. The court has said that there is no case against Kejriwal. There is no evidence against Kejriwal. BJP says that Kejriwal is a 'chor' (thief). The court said that there is not enough evidence even to hold a trial...If they can jail a sitting CM then what status (aukaat) do you have?...They keep everybody under fear," he said.

The AAP leader alleged that in Gujarat nobody is prospering except BJP and Congress leaders and that leaders of the two parties have joint businesses.

He alleged that after elections the leaders abandon voters and remain interested only in making money. "I was seeing that there are many MLAs in Gujarat who have properties worth over Rs 100 crore...Where did all the money come from?" he sought to know.

He said, "In the elections of 2027, (we) do not have to change the party. Enough is enough. Sometimes this party, sometimes that party. This time we have to change the 'vyavastha', we have to change the entire system."

Promising the people to bring a "people's government", Kejriwal said that it will function as per people's wish. In his speech, he also referred to initiatives taken by the AAP governments in Delhi and Punjab.

Also accusing BJP and other leaders of indulging in nepotism and promoting their children, Kejriwal said that he would never give tickets to his children.

give tickets to your children...All of you join AAP...Your child will become an MLA, minister and chief minister." In this context, he cited names of AAP leaders in Gujarat who are first generation politicians.

"This time it won't be a triple engine government, but multiple engine government. Farmer will be engine, trader will be engine, woman will be engine, youth will be engine. The six crore people of Gujarat will be the engine of the government," the former Delhi CM said.

"When your government is formed, what will you do? First of all, we will end hooliganism and corruption of these leaders. We will teach these leaders a lesson. Those who have looted Gujarat till date will be sent to jail. When our government is formed, a common man will get respect. When you go to a government office, you will get respect. Your work will be done...The government will function as per your orders," he added.

"All of you, shun BJP. Shun Congress. This time form your own government. Work for yourself. Press the button of 'jhadu' (AAP election symbol) and form your government," he said.

At the end of his speech, Kejriwal administered an oath to the audience not to vote for BJP or Congress in any of the upcoming elections.

AMC starts pilot project to make soap from Holi pyres ash, discarded peels of citrus fruits

TAKING THE Ahmedabad Municipal Corporation's 'eco-friendly' campaign a step forward, the civic body's Cattle Nuisance and Control Department (CNCD) has started a pilot project to make soaps from the ash from Holi festival pyres and discarded peels of citrus fruit from juice centres.

The CNCD distributed 251 Vedic Holi kits made out of cow dung across the city and after the celebration of 'Vedic Holi' and collected 300 kg of ash from seven places.

"While working with murti artists during Ganesh Chaturthi last year, the idea was floated by them to make soaps using ash and peels of oranges, lemons and mausambi - all items which otherwise are considered waste. We all know that in old times our ancestors would use ash to clean utensils. It was then we decided to make the best out of waste and use the Vedic ash from Holi celebrations and the peels from juice centres," CNCD head of department Naresh Rajput told *The Indian Express*.

A pilot project to make organic soap from ash and fruit peels has been started at CNCD's Karuna Mandir in Bakrol and Danilimda. The soaps will be distributed free of cost to the visitors of Karuna Mandir, Rajput says.

However, AMC has plans to scale up this initiative, officials said.

## CM inaugurates projects in his Assembly segment hours before AMC elected body's tenure ends

JUST A few hours before the Ahmedabad Municipal Corporation's (AMC) elected body's term ends on March 9, Chief Minister Bhupendra Patel on Sunday inaugurated several infrastructure projects in his Assembly constituency of Ghatlodiya. On Saturday, the Gujarat government appointed Additional Chief Secretary Education Mukesh Kumar as the administrator for the AMC as the five-year term of the elected body ends on March 9 and the civic elections could not be completed before the expiry of its duration.

Patel inaugurated the newly constructed water distribution station in the Ghatlodiya ward of Ahmedabad, sub-zonal office at Bodakdev and laid foundation stone for the Government Chavdi (Sarkari Chavdi) of the Revenue Department and the offices of the Food and Civil Supplies Department at Ghatlodiya.

The new water distribution station has been constructed at a cost of Rs 55.31 crore in the Ghatlodiya Ward, located in the North-West Zone of the AMC. The station has an underground tank and pump house with a capacity of 250 lakh litres and an overhead tank with a capacity of 25 lakh litres. With this facility, around 1.25 lakhs residents will receive water with adequate pressure and supply, AMC authorities stated.

The CM also inaugurated the newly constructed Bansibhai Pranlal Patel Bodakdev Sub-Zonal Office of the AMC. The new administrative centre will benefit citizens living in areas under the West Zone. With the functioning of the modern sub-zonal office, residents of Bodakdev and nearby areas will no longer need to visit the main zonal office. The building is equipped with modern facilities for tax collection, a civic centre, and various administrative services, directly benefiting residents.

With the construction of new building of the Government Chavdi (Sarkari Chavdi) of the Revenue Department and the office of the Food and Civil Supplies Department at Ghatlodiya, Ahmedabad, citizens of the Ghatlodiya area will be able to access government services more easily at one place, AMC authorities added.

## Jalore: Man cuts off mother-in-law's nose

Jaipur: A man allegedly attacked his mother-in-law with scissors and severed her nose following a family dispute in Rajasthan's Jalore district, police said on Sunday. The accused, Sohanlal, fled the spot carrying the severed portion of the nose after the attack, they said. The incident occurred on Friday evening in Dungari ke Bandha village.

Sohanlal had a long-standing dispute with his wife's family. The couple got married about six years ago, according to police. The husband and wife had been living separately for nearly a year following marital discord, and attempts by community members to resolve the dispute had failed. Police said tension had been brewing between the families for several days, and a heated argument had taken place at the house on Friday. Later in the evening, the victim, Keli Devi, was on her way to the local police station to lodge a complaint against her son-in-law Sohanlal when he allegedly attacked her with scissors and cut off her nose. "The family members have taken the woman to Mehsana in Gujarat for treatment," police said.
